## JOB DESCRIPTION

As part of the Specialist Care Team you will be required to facilitate clinical and holistic care to babies, children and young people in our care. You will be required to work in our Woodlands inpatient unit, our families' homes and in the community, delivering the highest quality family-centred palliative care. You will need to be available to work a variety of shifts across a rota including days, evenings and weekends. There will also be regular travel across our operating region.

Specialist Carers provide care for children and young people with life threatening and/or life limiting conditions and support for their families and carers. This will involve working collaboratively with the family, and internal and external multidisciplinary teams and colleagues. You will use your skills, knowledge and expertise in a variety of situations within the hospice as well as out in the community and in family homes. You will be trained and competent to work as a lone worker in the community. Shift patterns will include a rotation of weekend, bank holidays, early morning/evening and night shifts, which are an integral part of the service delivery.



You will safeguard all children and young people accessing our services, by responding to concerns raised in a timely and appropriate manner and effectively escalating these in accordance with policies and procedures.

#### **ABOUT YOU**

You will work with babies, children and young people with life threatening and life limiting conditions, including children with special needs. You will enjoy creating experiences, activities and play for those in your care, as well as working with your team to ensure their clinical needs are met.

You will understand and adhere to policies and procedures at all times, underpinned by competency in clinical skills, and will be supervised by a Senior Specialist Carer and/or Registered Nurse.

A full driving licence and access to your own vehicle for business use is essential to cover our wide geographical operating region.

As a valued member of Noah's Ark Children's Hospice, we will offer you free uniforms, free DBS, ongoing professional support and role specific training. Time for travel will be paid, including free car parking and a generous mileage allowance.



#### **KEY TASKS & RESPONSIBILITIES OF THE ROLE**

## **CLINICAL PRACTICE**

- Ability to prioritise and innovate when working in partnership with babies, children, young people and families, demonstrating sensitivity to their individual needs by promoting play, inclusion, comfort, dignity, privacy and quality of life.
- 2. Undertake duties relating to the care and personal care needs of the baby, child or young person. This will include washing, feeding, play and general activities.
- 3. Provide a high standard of personalised holistic home care to babies, children and young people with life-limiting and life-threatening conditions.
- 4. Ensure the safety of the baby, child or young person by monitoring and reporting all concerns and any changes to parents and Nurse Team Leader as necessary.
- 5. Under the supervision of a Senior Specialist Carer and Registered Children's Nurses, provide a high standard of healthcare, always in partnership with the family.
- 6. Adhere to the personalised plan of care for each baby, child or young person and to Noah's Ark Children's Hospice's policies.
- 7. Work closely with the play team creating fun and exciting ways to help the development and wellbeing of the child/young person in their care.
- 8. Promote and sustain a suitable environment in which the baby, child or young person feels safe and comfortable, being aware of individual physical, social, emotional and spiritual needs.

#### **RESPONSIBILITY**

- 1. Work independently and autonomously once trained and assessed as competent, referring any concerns about a child's care immediately, in line with Safeguarding guidelines.
- 2. Attend 1:1 supervision and Specialist Carer team meetings as required.
- 3. Communicate with babies, children, young people, families and the multidisciplinary team in a professional way whilst respecting client confidentiality.
- 4. Work in partnership with other team members, the wider multidisciplinary team and other external/partner agencies who are also working with the same family.
- 5. Role model best practice that adheres to Noah's Ark values, policies and procedures.
- 6. Live Noah's Ark's values kindness, courage, and excellence.

## **EDUCATION**

- 1. Undergo appropriate training and competency frameworks to gain care competencies.
- 2. Complete all mandatory training and clinical training to support the role.



3. Understand your limitations and the importance of not providing care where you have not been trained or passed as competent; working within own scope of competency and being accountable for actions and omissions.

## **GOVERNANCE**

- 1. Have a knowledge of safeguarding children and young people.
- 2. Maintain accurate records in accordance with GDPR guidelines and confidentiality frameworks using the correct Noah's Ark documentation and databases.

We have created a space where children who are seriously unwell are accepted as they are, safe to play, explore, express themselves and build confidence.
